**PROPOSED NEW OFFICIAL FORM TO BE USED BY  
BELOW MEDIAN FAMILY INCOME DEBTORS IN CONNECTION WITH 22C  
[Statement of Reasonably Necessary Expenses]**

Currently, no Official Form exists on which a “below median family income” debtor can disclose and claim her reasonably necessary expenses allowed to be claimed pursuant to § 1325(b)(2).

Although some courts accept Schedule J for that purpose, Schedule J is inconsistent with the expense items that a “below median family income” may deduct from her total “current monthly income” reported on Line 11 of current Form 22C. For example, Schedule J does not include a deduction for withholding taxes, mandatory and voluntary retirement contributions, union dues, etc., yet those items are deductible from the 22C Line 11 “current monthly income” total. In addition, although a “below median family income” debtor does not claim allowed expenses under § 1325(b)(3) (which is used by “above median family income” debtors), the expense categories and allowances for the higher income debtors should also be reference points in judging the expenses that are allowable under § 1325(b)(2).

The attached proposed Official Form would provide a coherent method for “below median family income” debtors to claim their allowed expenses and document that those allowed expenses, when subtracted from the “current monthly income” reported on Line 11 of current 22C, equal the debtor’s “disposable income.”
